#### **DELIVERY TIMES AND SPECIFICATIONS**

- 2.1. Delivery times are given for guidance purposes only .
- 2.2. All the pictures and specifications of the products in the catalogue are for guidance and Mettifogo LTD reserves the right to make the necessary alterations.
- 2.3. Mettifogo LTD will try that the colours of the items match with the designs and logos printed but an exact correspondence cannot be guaranteed.
- 2.4. Mettifogo LTD reserves the right to withhold the supply of one or several orders if the Buyer failed to meet any of the terms and conditions; there are payments overdue or unpaid invoices or exceeded limit of credit.
- 2.5. Samples of a value over 1€ will be invoiced.

#### **PRICES**

- 3.1. The sales prices are given excluding taxes and are to be applied to the available products in our warehouse, the moment of the reception of the order.
- 3.2. Minimum orders are specified overleaf.
- 3.3. Standard and customized orders can be cumulated to allow goods leaving together.
- 3.4. The quotations given are valid for 30 days or until its expiry date.

#### **CUSTOMIZATION , PARTICULAR CONDITIONS**

The General Sales Conditions and the following particular ones will be applied:

- 3.6. In customized orders made by Mettifogo LTD the responsibility derived from the use of the designs submitted by the buyer will be exclusively his.
- 3.7. The margin of tolerance regarding the quantities manufactured will be 5%.
- 3.8. Manufacturing defaults will have 5% margin of tolerance. If the percentage was larger we will execute a contingency file.
- 3.9. The register of printing colours in flexography is not absolutely precise, and no compromises for non coincident colours will be accepted.
- 3.10. Do not use shades of a colour to avoid invoicing an additional colour. The results are not satisfactory.
- 3.11. Between 2 different productions, slight variation of colour tonalities, size, grammage, ink, whiteness and so on can occur. The ink colours of our Catalogue are for guidance only.
- 3.12. We strongly recommend not to surcharge the texts in the printings in order to improve the quality. Small objects cannot hold large texts.
- 3.13. It has to be taken into account that the same ink takes different colour tonalities depending on the product over which the printing is made.
- 3.14. The delivery times are for guidance only. If an order is cancelled for this or another reason, the preliminary work (design and clichè) will be invoiced if they had already been made.
- 3.15. The buyer will provide a design or an already made idea of what he needs to print, otherwise it will be considered an IMAGE CREATION. Please consult prices in that case.
- 3.16. We cannot show mock up samples of finished products. We will send computer designs and compositions for the customer's approval.
- 3.17. Fussy and constant changes of designs will be invoiced separately.
- 3.18. We send order confirmations by post and/or e.mail. The approval of an order will mean acceptance of design, prices, discounts, quantities...
- 3.19. The approval of a design will be extended to all details, including typing or orthographic mistakes if there were.
- 3.20. The preliminary steps to a printing (designs – clichè) are Mettifogo LTD's property and will not be forwarded to our graphic companies for its use, even if the buyer had defrayed costs of plates and designs .
